The WHO recognition of the National Influenza Centre at the L.V. Gromashevsky Institute of Epidemiology and Infectious Diseases of the National Academy of Medical Sciences of Ukraine, headed by Dr Alla Mironenko, will be discontinued as of 1 January 2020

Please find enclosed the terms of reference for the national influenza centres for both seasonal influenza viruses and influenza viruses of human pandemic potential. Official recognition by WHO is for one year and will be reviewed annually on the basis of the criteria for maintaining WHO recognition and the annual review of the compliance of the national influenza centres with the terms of reference.

I hope it will be possible for WHO to call upon the national influenza centre of Ukraine to provide expertise on influenza whenever necessary and to participate in the activities of the WHO GISRS, as well as to contribute to the joint WHO Regional Office for Europe/European Centre for Disease Prevention and Control influenza bulletin, Flu News Europe.
